Description

Established over 30 years ago, this 75% commercial cleaning company has high levels of repeat clients and an excellent profit margin of 35%! This business offers services including carpet cleaning (which makes up 85% of revenue), carpet patches and repair (10%), minor water damage repair, tile cleaning, and hard floor cleaning (combined the last 3 make up roughly 5%). Their client base is primarily made up of commercial housing units that are looking to have their floors cleaned or repaired in preparation for new tenants, but they also do residential cleanings as well. While they have utilized marketing tactics to bring in new residential clients, almost all of their commercial clients are either word of mouth/referrals or repeat customers. The assets included with this business consist of over \$400,000 worth of vehicles and equipment.

This business has everything that they need to keep operating as is, however, there is continued room for growth as they currently have a higher demand than they can serve. They certainly have no shortage of clients or revenue potential. A new owner who can focus on hiring and training will be able to take on additional projects.

The current team operates out of a 5,000 square foot space in Omaha, NE and consists of 6 carpet cleaning and repair techs, and the current owner and his wife handle the supervisory, billing, and scheduling work. They have offered a 6-month transition period, and if new owners are looking to transition to absentee or part time workers, this time could be spent hiring and training a new manager. Growth opportunities for this business would include hiring more carpet workers and an outside sales representative and expanding the service area.
